DISCUSSIONS

On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.



Chris Brausch, Sanitary Engineer, was present for a work session to discuss the request of Steven and Bridgette Swigart for release of their 2 acre parcel from the Warren County Water and Sewer Service Area to allow the City of Springboro to provide services.

Mr. Brausch stated that this property is adjacent to the City of Springboro and the city has agreed to provide services at the outside rate to this property. He explained that Warren County does not have lines near the property.

Upon discussion, the Board resolved (Resolution 22-0592) to enter into an agreement with the City of Springboro for water and sanitary sewer service to the Swigart property along Lower Springboro Road in Clearcreek Township.

Tiffany Zindel, County Administrator, discussed the desire of the Sheriff's Office to approve a Memorandum of Understanding with the union which would allow a supervisor to cover vacant shifts within the County Jail in certain instances.

Mrs. Zindel explained the current practice of mandatory overtime based upon the least seniority is causing burnout and turnover within the jail. She explained the desire to authorize the supervisor to cover the shifts when needed.

Upon discussion the Board resolved (Resolution 22-0593) authorize Tiffany Zindel, County Administrator, to sign a Memorandum of Understanding between the Warren County Sheriff and the Warren County Deputy Sheriffs' Benevolent Association, to amend the following Collective Bargaining Agreements: Non- Sworn Employees, SERB Case Numbers 2019- MED- 07- 0646; 2019- MED- 07- 0647; 2019- MED- 07- 0648, specifically Sections 22.9 and 22.10, to allow Corrections Supervisors (Unit B) to work overtime in the Corrections Office (Unit A) bargaining unit.

Tiffany Zindel, County Administrator, stated that the Drug Task Force has an opportunity to apply for one-time grant funds which can be utilized to offset salaries.

Upon discussion, the Board stated their approval to apply for the grant funding.

Doug Koenig, President of the Warren County Airport Authority, presented an update on the Warren County Airport.

Mr. Koenig stated that the updated master plan is underway and should be ready to send the final draft to the FAA this summer. He also stated that they currently have 116 aircraft at the airport with a waiting list that is growing.

Eric Fields, property owner at 2355 Greentree Road adjacent to the Warren County Airport, was present for a work session to discuss the vacant property that adjoins his parcel owned by the Board.

Mr. Fields stated that the previous owners had a verbal agreement with the previous Airport Authority Board that allowed them to utilize the property as pasture. He stated his desire to formalize an agreement that would allow him to fence the property and use it as pasture for his horses.

Bruce McGary, Assistant Prosecutor, stated that the previous Airport Authority President gave permission to the previous owners without authorization from this Board of Commissioners. He stated concerns relative to possibility of losing the tax exemption on real estates taxes as well as the FAA grant requirement of fair market rent.

There was discussion relative to the agreement to use the property for agricultural use only in exchange for maintenance and upkeep of the land as well as the understanding that the removal of any fencing would be required if and when the Board ever determined the need for the property at his sole expense.

Upon discussion, the Board requested Mr. McGary to prepare an agreement that allows the use of the property as pasture only with all of the stipulations previously discussed being included.

Barney Wright, Warren County Treasurer, was present along with James Spaeth, Clerk of Courts, for a meeting of the Warren County Investment Board.

Mr. Wright presented the attached update on the County's investments. He stated the average duration of our investments is 1.8 years and as interest rates rise, he will reinvest.

Neil Tunison, County Engineer, was present for a work session to discuss the need to update the current Roadway Standards.

Mr. Tunison stated that he has been working with the township trustees as well as the area Homebuilders' Associations on updating standards and regulations relative to roadways. He then stated that upon completion, estimated to be in June 2022, he will request the Board to approve the updated standards.

On motion, upon unanimous call of the roll, the Board entered into executive session at 10:11 a.m. to discuss acquisition of property pursuant to Ohio Revised Code Section 121.22 (G)(2) and exited at 10:35 a.m.








SECTOR ALLOCATION




SECTOR ALLOCATION
